OSHA'S BROCHURE ON BANNING TEXTING WHILE DRIVING

Although OSHA does not have a specific standard addressing texting while driving, OSHA has published a brochure advocating that employers prohibit texting while driving. OSHA cites the following as some of the dangers of distracted driving:

- Distracted driving resulted in 5,400 deaths and nearly 500,000 injuries in 2009.
- Texting while driving claimed more than 16,000 lives from 2001 to 2007.
- Reaction time is delayed as much as for a driver who is legally drunk.
- Drivers who are texting take their eyes off the road 400% more than those not texting.
- More texting leads to more crashes.



As a result, OSHA suggests clear explicit policies and sound practices, and suggests that employers do the following:

- Prohibit texting while driving, and declare vehicles "text-free zones."
- Set up clear procedures, times, and places for drivers' safe use of texting and other communication technology.
- Incorporate save communication practices into worker orientation and training.

High Visibility Clothing

It's that time of year again when the weather begins to improve and road construction to repair all of the winter damage begins. It's obvious to see the benefits of high visibility clothing for employees working on the highway and on construction sights, but also it's imperative to consider its necessity in manufacturing and distribution facilities. The definition for High Visibility Clothing is listed below:

"High-visibility clothing, a type of personal protective equipment (PPE), is any clothing worn that has highly reflective properties or a color that is easily discernible from any background. Part of the surface of the garment may have reflective stripes. This way they become much more visible in the dark for observers near a light source, such as the driver of a car with its headlights on. The pattern of the reflecting parts also helps to distinguish between objects and people. For greater visibility during the daytime, very bright colors are used for the main body of the garment by means of fluorescent material."

Many industrial and distribution companies are now taking a very serious look at getting most if not all employees into safety vests or high visibility T-Shirts. Safety Equipment distributors can also provide you with high visibility rainwear as well as sweatshirts, coats and hats in many styles and designs. The value for your workplace is that employees will be highly visible during early morning or late evening hours as well as throughout the course of a normal workday. Employees that are working in, near and around forklifts are also perfect candidates for this potential life-saving, low cost safety improvement. This clothing can be made with your company logo as well. The costs for this type of clothing are often much less than you would think and the benefits are reduced workplace accidents, lower workers compensation costs, improved employee morale, and most importantly your employees get to go home tonight healthy and whole.

Question: Is it written anywhere that vehicle lights must be used during rain?

Answer: Yes, there is a Law within the Ohio Revised Code, 4513.03 (which can be found at <http://codes.ohio.gov/orc>) that references the question. Anytime the windshield wipers of the vehicle are in use because of precipitation on the windshield, the vehicle lights shall be turned on.

2. **Don't forget to sign-in.** If you do not sign the "sign-in sheet" your company will not receive credit for attending. This could hurt your company's chances of receiving the BWC's discount.
3. **July 1, 2010 began a new 12 month period** for the BWC's rebate program. If your company is eligible, you must attend a minimum of 10 events, with your company's CEO or a senior level manager attending one of these 10, and submit two semi-annual reports.
